



Cybersecurity Awareness Month Webcast Prize Draw Official Rules

NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The Cybersecurity Awareness Month Webcast Prize Draw (the "Promotion") begins at 1:00 p.m. EST on October 3, 2018 (the "Promotion Start Date") and ends at 4:00 p.m. EST on October 24, 2018 (the "Promotion End Date"), such period referred to herein as the "Promotion Period." The Promotion is sponsored by Sophos Inc. (the "Promotion Sponsor"). The Promotion Sponsor's computer is the official clock for the Promotion.

1. How to Enter: To enter the Promotion, an individual must register for and attend a Sophos webcast from the "Threats and Solutions: Raising your Cybersecurity Awareness Monthly Webinar Series" during the Promotion Period.

Limit to one (1) entry per person during the Promotion Period. Participation in the Promotion is voluntary and does not require you to purchase anything from the Promotion Sponsor. No illegible, incomplete, forged or altered entries will be accepted. All entries must be received by the Promotion End Date. Mechanically produced or reproduced entries not accepted. The winner will be notified by e-mail using the information provided during the webcast registration process, within thirty (30) days of the Drawing Date. In the event the winner does not accept the prize within five (5) business days of such notice, the winner is ineligible, or the prize or prize notification is not deliverable, an alternate winner may be contacted. The Promotion Sponsor is not responsible for and shall not be liable for late, lost, misdirected or unsuccessful efforts to notify winners.
